NOTES: A Site plan is required that shows where the fence will be located in relation to property lines. If a property owner wants to install a fence closer than 2' to a property line, the owner must be able to show the property pins to verify the property line. Contractors/Installers must be registered with the City. The attractive/finished side of the fence must face away from the property owner's property. Fences must be constructed from materials specifically designed for residential fences. Wood pallets and farm fencing (.i.e chicken wire) is not allowed. Fences may not be constructed or placed closer than 2' to any public right of way (streets & alleys). No fence shall be constructed or placed in such a manner that visibility is obstructed from intersecting streets or alleys (15' triangle clear area). Fence posts must be placed 36" deep. (If renting a post hole digger ask for an extension.) It is the responsibility of the property owner installing or constructing the fence to determine the location of the property lines and to insure that the fence so installed or constructed does not encroach upon the adjoining property, lot or right- of-way, or any restricted easements.

INSPECTIONS: A site visit will be required to review the location of the fence prior to installation. Pole hole depths will also need to be verified and a final inspection is always required. Call for inspections a minimum of 48 hours in advance. A fee of \$25 will be required for reinspection.

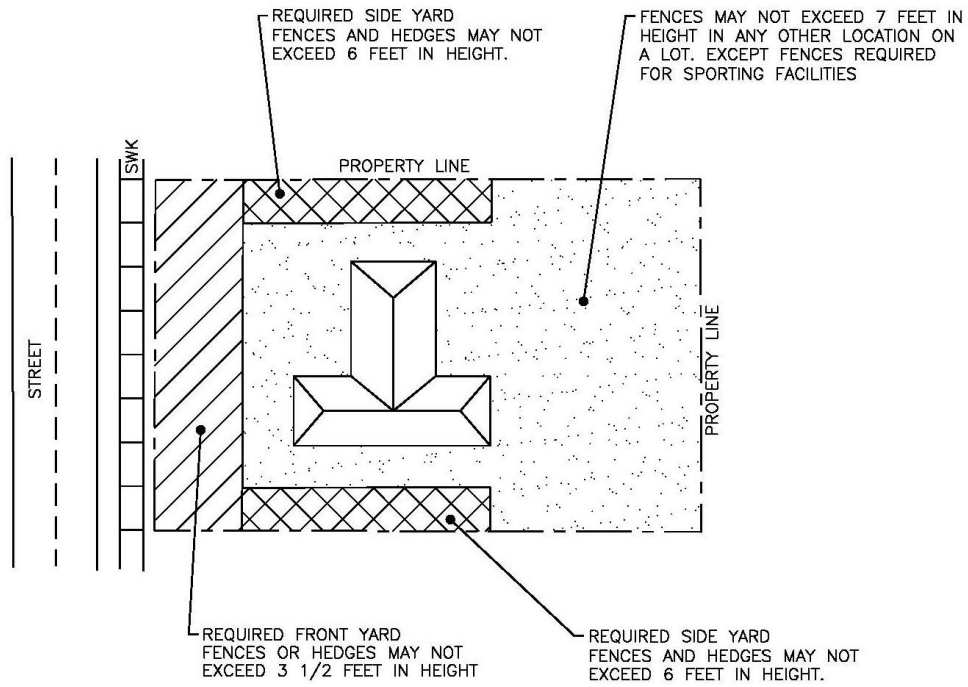
